NRW officers Phil Harper and Dave Wilby visited Cymru Lan Cyfyngedig, Plot 4, Gaerwen Industrial Estate, Gaerwen, Anglesey, LL60 6HR on the 6th February 2020 at 11:50 am. Tom Cumberland and Barry Rowlands accompanied the visit.

The weather was dry and sunny. The site was operational but little activity was noted.

After signing into the visitors book a tour of the operations was provided.

The site was well maintained with no litter. The concrete surfaces were all in good order and drains were visibly free from any material.

All mixed waste within the waste transfer building was appropriately stored and all areas outside the storage bay were free from litter.

All on site waste streams were clearly segregated.

Quarantine areas in the middle of the yard and transfer building were clear from materials as specified in the Fire Prevention and Mitigation Plan.

The fallen stock facility was active with activities remaining within the designated building.

F1 Odour

No odours on site or outside of the site boundary.

F2 Noise

Site was operational during the inspection, no excessive noise.

F3 Dust/fibres/particulates and litter

No dust on site, no litter outside of the site boundary.

F4 Pests/birds and scavengers

No vermin on site.

F5 Deposits on road

No deposits or mud on the road outside the site.
