NRW officers visited Abergele CA site, Old Gofer Landfill Site, Rhuddlan Road, Abergele, Conwy at 13:55 on the 16th December 2019 accompanied by Daniel Maccabe, site manager.

Conditions were dry and overcast.

WAMITAB certificates on site show that TCM cover is provided for the site.

1. Specified Waste Management Operations

Visually less than the maximum storage capacity of 250 tonnes on site.

Discussed the treatment of sofas on site by crushing using plant. This is a permitted activity on the site. Electrical waste including fridges were stored in a cage. There was plenty of capacity within the cage for further waste items.

3.1 Provision of Site Identification Board

Site identification board is present and displays the required information as described by the permit. When renewing the sign please use the Natural Resources Wales incident hotline **03000 65 3000** as contact number.

4.2 Leaks and Spillages

It was demonstrated to officers that spill kits were present on site and easily accessible if required.

4.4 Waste Acceptance and Control Procedures

While officers were on site members of the public arrived at the site to deposit waste, they were greeted at the site entrance by site operatives who checked what waste was present and assisted in segregating the waste into the correct skips and containers.

4.6 Storage of Wastes with Specified Hazardous Properties or Forms

Hazardous waste storage box was locked and secured. The asbestos skip was locked and secured.

5.5 Control of Litter

Litter net in position around the site, minimal evidence of windblown litter around the site.

No odours or vermin on site.
