On the 9th December 2019 at 10:50 am NRW officers Phil Harper and Julie Hughes carried out a site inspection at Llwyn Isaf Anaerobic Digestion Site, Clynog near Caernarfon, Gwynedd.

Weather Conditions were damp and overcast,

Induction was provided by Steven Hembrew prior going on site.

A visual inspection of the site was carried out accompanied by Steven Roberts, Head Engineer- one small leak was identified on a manifold on digester two. The site was aware of the leak because remediation in the form of a drip tray was in place. The leak had already been noted by site personnel and plans were in place to carry out a repair.

1. General Management

It was demonstrated to NRW officers that all staff on site have attained the correct WAMITAB qualification for activities on site and all qualifications are in date.

3.3 Odour

No odour outside of the site perimeter.

3.4 Noise and Vibration

Officers determined that there was no noise caused by the site, outside of the site boundary.

3.6 Pests

An inspection of the pest control diary was undertaken. There were no issues on site.

Schedule 2- Waste types, raw materials, fuels

Waste returns from 2018 show that the facility accepted 11,327 tonnes of waste in 2018. This is below the limit of 11,500 tonnes

Please be aware that emissions monitoring data is due in January 2020.

No other issues were identified during the inspection, NRW officers left the site at 11:45 am.
