Compliance Assessment Report – Volehurst Limited

Officers Jonathan LEE and Rhydian COX in attendance of Volehurst Limited to complete a routine compliance inspection of the permit **EPR-KP3595FB**. Weather was cool with light rain.

Officers completed a short walk over of the site with company director Mr Webb. Mr Webb gave details on recent activity of the site, site operations and destinations for outgoing waste streams. All mechanical and hand sorting of waste was being completed on the area of impermeable surface. No issues were noted regarding infrastructure or the storage of wastes on site. Site diary was inspected and appeared to be in continuous use. Duty of care waste transfer notes were briefly inspected, no issues apparent.

Compliance

The following actions were identified during the inspection.

C1 – Staff Competency and Training – Permit Condition 1.4.1 – Action only

Permit condition 1.4.1. requires any changes in the technically competent management (TCM) of the site to be submitted to Natural Resources Wales. In addition, permit condition 1.3.4 requires the attendance of the TCM

At the time of the inspection, it was noted that the TCM of the facility had recently changed.

Action – Submit evidence of technical competency. Ensure that presence of the TCM on site is recorded in the site diary.

G4 – Reporting and notification to Natural Resources Wales – Permit Condition 6.2.2 – Action only

Permit condition 6.2.2 requires the submission of quarterly submissions of waste returns which indicate

the quantity and type of waste accepted and removed from the site.

Upon review, the following quarterly waste returns have not been submitted to Natural Resources Wales; Q2 2019, Q3 2019 and Q4 2019.

Action – Submit outstanding quarterly waste returns.
