NRW is moving towards place-based regulation and have divided Wales into six areas. Abril Industrial Waxes are now based in the south-central area but the current regulatory officer is based in the south west, hence the need to transfer the regulatory responsibilities to an officer who is based in the south central area. Your new officer is Geraint Harris who is based out of St Mellons Cardiff. However, In light of the UK Government implementing further measures to delay the spread of Coronavirus all site visits will be postponed until later in the year.

***Form E1***

Energy consumption decreased by 17% in 2019, which is a consequence of a reduction in production by 15%. However, efficiency improved with a slight reduction in CO<sub>2</sub> produced per unit output.
