The site is used to store waste materials for reuse recovery and disposal. The whole site benefits from a sealed drainage system.

Hardcore material is being crushed and stored for reuse. Please ensure use of this material is rotated as the maximum storage time is 3 years for recovery.

The waste was well sorted and the site clean and tidy.
