Results of the OSM compliance sample from Llidiardau STW - CG0354201 returned a pH result of 5.6. Schedule 3 of permit CG0354201 sets out that the pH of the final effluent must be between 6 and 9.

As this failure is within 20% of the consented limit this breach has been classed as a Category 4 non compliance, with a Compliance Classification Score of 0.1. In this instance we will not be taking any further action, however our decision could change if any further relevant information comes to light.
