Officer JAK ROSE attended Penallta Civic Amenity Site for a routine visit of permit **EPR- EP3795FQ** The weather conditions consisted of light drizzle with overcast conditions and a brisk wind at the time of visit.

Officer ROSE was accompanied by Rhodri LLOYD - Principal Waste Management Officer, Ricky VAUGHN – Waste Management Officer, Scott JONES – Waste Treatment and Disposal Supervisor.

Various areas of the Environment Management System (EMS) were covered during the audit we discussed matters in relation to:

Materials acceptance procedures

Storage procedures

Accidents and incidents procedures

Staff training

Site security

Drainage

The site was closed at the time of visit as it closes every Wednesday and Sunday. The gates were locked and the site had no other members of staff present during the visit. They explained that they had some issues with fly tipping by the boundary fence, the road leads to a cul-de-sac at the end of an industrial estate.

All of the signage was correct and they have recently implemented new signage advising the public to show proof of their address. A photo showing a driving licence informing visitors that they must reside in the borough in order for the waste to be accepted. All staff have received training on what checks to carry out prior to receiving the waste types.



With some items such as batteries and waste oil, the staff offer to take the waste from the residents vehicle in order to reduce the risk of accidental spillage. The bunded oil container was free of leaks and appeared to be in good condition. Spill kits are made available in the yard office.



In regards to the training they provide to staff, it consists of a week period as part of their induction at the HWRC. Once they have spent one week learning how the site is operated they return to routine refuse collections. Once a group of staff have been trained they are then placed on a rota basis for the six HWRC's in the borough.

The Penallta site has largest yard area out of all of the six HWRC's, therefore it is used as means to store some of the empty or decommissioned skips. There were several being stored at the time of the visit. The skip repairs are undertaken by Caerphilly Skips who either take them away or repair them on site.

The site was free of litter and the drain interceptors are maintained on a quarterly basis. They had recently had them emptied due to the heavy rain.



Scott has recently completed his renewal of the WAMITAB qualification and sent proof of his continuing competency after the site visit was completed.

Waste returns are up to date and submitted on a quarterly basis, there are no concerns with the data. Thank you and please continue to do this.
