Officer JAK ROSE attended Lawn Civic Amenity Site in Rhymney for a routine visit of permit **EPR-QP3899FY**. The weather conditions consisted of light drizzle with overcast conditions and a brisk wind at the time of visit.

Officer ROSE was accompanied by Ricky VAUGHN – Waste Management Officer and Scott JONES – Waste Treatment and Disposal Supervisor. The Rhymney site is closed every closed every Tuesday and Friday.

The site was open to the public and operational during the visit. There were two members of staff present on site. One of them was at the entrance of the site and the other was at the skip bins awaiting residents with their waste.



The staff member at the front of the premises would be checking visitors proof of their address. A large

sign showing a driving licence on the outside fence informs visitors that they must reside in the borough in order for the waste to be accepted. All staff have received training on what checks to carry out prior to receiving the waste types.

There was one skip that appeared damaged. Scott was intending to remove the skip from operations and carry out repairs. As seen from the photo the metal has been worn down from continuous use. Please ensure that holes are not allowed to get bigger as waste could potentially leak out from the bottom of the skip bin.

Scott has recently completed his renewal of the WAMITAB qualification and sent proof of his continuing competency after the site visit was completed.

Waste returns are up to date and submitted on a quarterly basis, there are no concerns with the data. Thank you and please continue to do this.

Advisory notes

There were some fragments of ceramic tiles that were across the boundary fence. These were next to the ceramic skip bin so it could have been a case that when they were smashed they escaped the skip bin. Please ensure waste is kept within the site boundary and cleaned up immediately.

Please complete the repairs to the skip mentioned above.

Along the fenceline at the front of the site there were some bits of litter that had escaped. Officer ROSE advised that the plant growth at the front may cause some litter to become and hidden and trapped.

N.B. The expiry date for the Continuing Competency on the Waste Return Spreadsheet needs to be updated as the date has expired
