Officer JAK ROSE attended The Amber Engineering Ltd Transfer Station for a routine site inspection in respects of permit **EPR-XP3295FK**. The weather conditions consisted of light drizzle with overcast conditions at the time of visit.

Officer ROSE was accompanied by NRW officer(s) Alex BOWDER and Rhys HANDLEY. From Biffa we were accompanied by Adrian PITMAN who was the Site Supervisor.

Officers were taken to each part of the site, beginning in the South-East corner of the yard. Here there was one stockpile of scrap metal and one other pile of wood. See below.



Officers then headed towards the existing building, where there still remains some damage to the panels. The structural integrity seems to be unaffected and all areas remained enclosed.

There was a quantity of residual waste within the building which was awaiting to be sorted. See below.



Within the building was a Waste Sorting Line with skips for collected recyclables beneath. This was no longer in use and Aide advised us that they were planning to transport it off site in order to put it to better use.

Infrastructure

The rest of the yard appeared to be in good conditon with no signs of damage to the surface area. There were some pooling of surface water which is to be expected due to the rainfall.

There was a minor breach on the previous inspection, drains in the yard were blocked at time of visit, which allowed potentially contaminated water to pool on site and significant potholes and damage to the yard surface. This has been remediated, thank you for completing this.

General Management

The RDF at the back of the site (North side) was in the process of being transported off site. The Site Supervisor informed us that the waste is kept for no longer than stipulated in the EMS.

The storage times for sorted RDF waste according to operating guidelines is no longer than three months.

The bays will be relocated to the enclosed building according to Aide. See below.

Please can you send an updated certificate of continuing competency as the latest waste return shows it expired on 12/01/2020.
