Results were compliant with permit conditions.

Condition 2.3.3 (a) Table S3.2 (EWC Codes)

On 18/04/2019 Biffa correctly informed NRW under condition 4.3.1(b) that the Cardiff site had received 1 x 60l container (weighing 15kg) of material with the EWC code 180108* which was not permitted.

Biffa identified that the system to stop inappropriate EWC codes into site failed on this occasion and the receiving chemist also made a mistake on receiving this EWC. The waste was sent onto a licenced disposal outlet.

There was no environmental impact from this incident, and the potential risk was low, although it is important to ensure that waste is correctly identified to prevent incidents from incompatible materials etc. As such we have scored a minor non-compliance Category 3. NRW will review site procedures at the next visit, at which point we will review potential root causes.
