A Schedule 5 notification has shown a breach of permit limit for effluent discharge from your facility into the Afon Erch. The breach in question on this occasion was for BOD. This breach was sampled on the 27<sup>th</sup> March 2020.

Permit condition 3.1 states:

**3.1.1 There shall be no point source emissions to water, air or land except from the sources and emission points listed in schedule 3 tables S3.1, S3.2 and S3.3.**

**3.1.2 The limits given in schedule 3 shall not be exceeded.**

The limit for BOD is 20mg/l and the reported value was 37.2 mg/l.

The CCS score on this occasion is a CCS 3 as this was a minor breach.

Continue to check the sampling procedure and, sample storage and transport. The proposal for the construction of the new ETP should continue when possible, but the current discharge parameters must be controlled and reasons for breaches thoroughly investigated pending planning and construction of the new ETP.
