Annual Returns

Site sent the following reports through on time. A2, E1, PI1, R1, and S1. These have been evaluated with the following comments;

- A1 PCDD/F to air permitted maximum is 0.1ng/m³. Site returned 0.097ng/m³ with an uncertainty of 18%. This is within limits but needs to be closely monitored to ensure limits are not breached.
- E1 – We note a 25% increase in CO₂ per tonne of product over figures from 2015-2018 inclusive.
- R1 – Note that slag is approximately 15% of the total finished product. Dust is approximately 2% and metallic scales are approximately 0.2%.
- S1. The spot samples for S1 and S2 were identical. On querying this, the site showed that the samples drain into the same receiver, so one sample covers both. This is acceptable for this area.

Annual Report 4.2.2.

- This was sent on time and accepted in full.

Schedule 5.

- We received a schedule 5 notification on 23rd Jan for a breach of the permitted level of 24-hour average of particulate matter. This will be evaluated at the end of the Q1 period Jan – March 2020 with any other exceedance of permit limits within that quarter.
