Incident reported to NRW on 28th December 2019, Polfax was sent to DCWW however crew was on site at the time of receiving the POLFAX.

DCWW crew investigated the reports of grey water discharge in to a high flowing river, cause was a mass blockage of wet wipes with in the chamber caused by third party, this was cleared and normal flow resumed, the permit allows discharges at high flow times and the enviromental impact was very minor due to high river levels
