A site inspection was undertaken on Monday 16th March 2020. The purpose of the inspection was to assess compliance with the Environmental Permit in areas of the site that were previously inaccessible. Natural Resources Wales officers undertook an inspection on 5th December 2019 and certain areas of the site were inaccessible.

An inspection was undertaken on Monday 16th March 2020 and the following observations were made:

Site Access

This inspection was conducted following a period of very heavy rainfall. Due to the nature of the waste (earth, soil, stone) certain areas are heavily laden with wet earth and mud. This poses a risk to staff/stakeholders, especially if they are lone working in these areas. It is suggested that measures are taken to mitigate this issue. Hazards must be identified and clearly communicated to staff/stakeholders.

We may consider suspending permitted operations in areas of the site that staff feel are unsafe/inaccessible.

Site Drainage & Infrastructure

In the far right corner to the rear of the site (upon entering site) officers noted that site surface water run-off, that was contaminated with silt, was escaping site and entering the adjoining property. You must contain surface water run-off on site.

Condition 2.3.1 of the Environmental Permit was breached (Category 3 - Minor) (Ref:B3)

Waste can only be stored in areas of the site that benefit from a sealed drainage system. You must take action to prevent surface water run-off from escaping site.

No other non-compliances of the Environmental Permit were recorded in the inspection.
