Response to ORML1938 request for further information 160420

On 29th of October 2019 Menter Môn Morlais Limited ('Menter Môn') of Llangefni Town Hall, Llangefni, Anglesey, LL77 7LR applied to Natural Resources Wales for a Marine License.

Following Natural Resources Wales' response to the application, further additional environmental information was submitted on the 27th of March 2020. Following a review of the materials Natural Resources Wales' Marine Licensing team have required further clarification and documentation to support the submission.

We are also providing a draft of a suggestion for a proposed condition for the Marine Licence to secure the EMMP and associated requirements. The purpose is to try to demonstrate our understanding of how a condition can address NRW's concerns and provide NRW with the control that they are seeking
