A routine inspection of Penlan Civic Amenity Site was carried out on 5th December 2019. The weather was overcast and dry. Sally Wakeford, James Kinkead and Michael Edwards from NRW were present during the visit.

Waste Storage.

At the time of the visit the site was quiet. The site management was very good – all waste containers were clearly labelled and in good condition. Waste was segregated well (examples can be seen in images 1, 2 and 3) and the site was generally tidy of loose waste. Quarantine containers were well labelled and appeared to be in use (see images 4 and 5).

Site Infrastructure.

The site was in good general condition. All areas were tidy and free of loose waste inside and out of the fenced perimeter. Signage was appropriate and clear, and areas were well marked on the ground. No pooling of water or faults in the site infrastructure were observed. We were informed that the drains had been cleared a few days prior to the visit and no obvious obstructions were observed.

Site Documentation.

The site diary was checked and is being updated well.

Other observations.

Site staff explained that they had been experiencing some issues with members of the public throwing waste over the fence when the site was closed, however staff were aware of this and endeavour to clear this into the appropriate containers as and when it occurs.

Spill kits were available on site and staff were aware of their location.

Containers for wood disposal were recently removed from this site. Staff were aware of the issue so that the public could be informed of alternative sites that could take this waste type (Llansamlet CA).

NRW would like to thank Jimmy for his enthusiasm and time while we carried out the inspection.
