On 22nd Nov 2019 Tony Bruten an Environment Officer from Natural Resources Wales carried out a routine inspection of permitted Poultry Unit, Croft y Loi. Permit number EPR/AB3098FG

Permit Condition 1. General Management, Energy Efficiency, Use of raw Materials and disposal of wastes. All documentation was in order and up to date. There were no breaches of any of the required documentation or activities.

Permit condition 2. Operations. The operations being carried out on site were as specified in the permit. The site was in excellent condition with no requirements to be carried out. There were no risk of pollutions at time of inspection. All animal placements and movements were correctly recorded. Record of dead livestock leaving the unit was all in order.

Permit Condition3. Emissions and monitoring. There were no issues with any emissions to water, air or land. All storage of liquids were as required with oil in bunded tanks. There were no recorded complaints of odour or noise issues.

Permit Condition 4. Records - All records were kept at site and easily available for inspection, they were up to date and relevant information was recorded.

Permit Condition 5. Reporting. There were no problems that needed reporting to NRW.

There were no breaches identified during the inspection and the site was in excellent condition. All documentation was well presented and all necessary notices were clearly displayed.
