Compliance visit carried out by Natalie Wrangham and Llyr Thomas. We met Kevin Betts, DCWW Water Resources Technician on site.

On the day of the visit the borehole was not in operation. Kevin explained that it was shut down until DCWW had received the test results taken a week earlier to determine the water quality. These tests were conducted after a dead fox was found in the borehole. Kevin advised that the borehole isn't routinely used as it is not cost effective to pump the water from the borehole when there is water available from other sources which is abstracted via gravity. He explained that the borehole can go artesian and there is an overflow channel leading to a brook for the water to discharge to, preventing flooding of the borehole building. This channel is screened to prevent unwanted access of people and animals.

Kevin sent the abstraction data for the last 12 months via email on 15/08/19. The data shows that abstraction from the borehole has been intermittent and well below the licensed maximum quantities.
