The abstractions from the 3 watercourses are all permitted under the same abstraction licence, along with an abstraction from Llyn Fawr reservoir. All can feed the Tyn-y-Waun reservoir or be directed to feed the Llyn Fawr reservoir. According to data records sent through on 25/07/2019 by Kevin, the abstraction from these sources under this licence is within the maximum licensed quantities.

During my visit I noted that the Garreg Llwyd intake was clear of obstructions and that water was flowing down the compensation notch (see picture below). There was also a large quantity of mine water entering the stream upstream of the intake which Kevin said can cause problems for them.





When I inspected the Nant Carnfoesen and Nant Melyn I saw that the intake weir and compensation notch had been obstructed with stones and a shoe. There was still flow passing the blockage, see pictures below. Kevin said he would send someone to remove the blockage.
