I met Kevin Betts on site to carry out a compliance inspection on DCWW Nant Selsig abstraction. This abstraction feeds into the Tyn Y Waun reservoir for public water supply.

The weather was dry and the water levels in the stream were low. The intake was screened and clear from obstruction, as was the compensation notch allowing flow downstream (see pictures below).





Kevin supplied abstraction data on 13/08/2019 which showed that the abstraction has been within the licence limits for the last 12 months.
