We discussed the current status on site.

Rob Gittins has not got the correct technical competence level at present. Phil Rees is currently overseeing Robs training and is acting as the Technically Competent Manager in the meantime,

I received an e-mail from Gower Chemicals dated 13/02.2020 outlining Phil Rees' responsibilities at the permitted site prior to you gaining your level 4 HROC6 WAMITAB competency.

### EMS

BSI audit the site every 12 months. You have provided me with the most recent Audit report. Please ensure all procedures related to the permitted waste streams are documented in your EMS.

### Registered Premise

You confirmed that the premise has been registered and that this will expire in August 2020. The premise code is the same as previous years - CAB 606 .

### Consignment Notes

We discussed the issue with the H codes and now that all units coming to you for reprocessing have been retrofitted only the H280 code is applicable. The EWC code 14 06 01 is an absolute entry in WM3 so until this gets revised the refrigerants you process still fit under this code.

There were a number of consignment notes coming into you from customers where the date and time were not filled in on sections C and D of the consignment note. We discussed the need to follow up and ensure this is corrected.

I also requested an updated OPRA score from the site for our records. I will await confirmation of this but this will not form part of the CAR form.
