Gower chemicals recover refrigerants gases. It is a well run site with good housekeeping.

Nickel recovery no longer undertaken. It was piloted but never took off.

- TCM

Rob Gittins has not yet gained his level 4 hazardous waste competence. This was highlighted over the last few years. Rob has been working towards this competency level and has said it will be in place by June 2019. I will score the site again for this. Please ensure a person with the right Technical competence is on site for the appropriate time until the level 4 competence has been gained.

- Consignment note H Code. The current H280 Code being used refers to pressurised containers so the H420 code would be the best fit for environmental hazards.
- Registered premise code is CAB 606 this expires in August 2019

- EMS

The document used for the permit application Sol – 0810GC requires updating to reflect the current activities carried out on site. Please ensure this is done by the next inspection.

The mango system is used to record weekly maintenance, and a number of other management activities. It is a live system and has proven a great asset in helping to manage and control issues around the site.

Procedure for hazardous waste returns needs to be added to the EMS.

The site is audited by BSI yearly.
