Amanda Hayes is the TCM for the site. Her continuing competency is up to date and expires in October 2019. Bob Sealey has also got a WAMITAB qualification but this does not cover Clinical waste.

The clinical waste is now being taken to SRCL in Bridgend. Natural UK are taking the offensive 18 01 04 waste from site. WEEE is taken by Waste Care Group. Please ensure pre-acceptance checks have been undertaken for any new contracts.

The waste tracking within the wards is still in place and all waste is coded in accordance with SRCLs classification for onward treatment and disposal.

There has been a query regarding the consignee returns not being submitted but during my visit it was established that the only waste brought onto site from outside is via the ambulance service so this will be exempt from the process.

There is still an issue with Dual coding of sharps. I will take this up with SRCL.

The registered premise number is CAD416 and this expires 25/10/19

The Healthcare Trust undertake an internal audit which Veolia are not involved with and do not get to see. An external audit is undertaken every 2 years by Lloyds Register. This was last carried out in October 2017.

External Waste storage areas

The external storage area are well signed. This is a secure area with good housekeeping. Bays with different clinical waste types are demarcated and signed appropriately. The impermeable pavement is in good condition.
