4.1.4 Fugitive Emissions Review 2019

This review was received on 23rd March 2019. There were no fugitive emissions in 2019. Various improvements have been made to the site to reduce the likelihood of fugitive emissions in the future. These include repair of some sub-surface and surface drains, repairs to the top of some bunds in the effluent treatment area and moving the chemical storage facilities inside, next to the plating plant. The CCTV system has been replaced and improved.

Replacement of the hydrochloric acid storage tank and associated scrubber is planned for 2020.

The report is accepted.

These forms were not received by the due date, probably because they are due at the same time as the annual reports, which may have caused some confusion.

All emissions for both quarters were within their respective emission limit values.
