On **31st May 2019**, a routine unannounced site inspection was completed at the site located at **Old Bridge Inn Padeswood, Mold, CH7 4JD** by regulating officer Carys Williams (Environment Officer) accompanied by Amy Henderson (Environment Officer). During the inspection officers were accompanied by Michael Scarfo (permit holder).

The site was last visited by Natural Resources Wales (NRW) on 15th December 2017, the previous inspection is detailed in Compliance Assessment Report: CAR_NRW0032708. There were no scores issued for the previous inspection.

The site diary was not on site, as Martin Womack (TCM) had taken it offsite. Martin visits site 2 times a week. Please can you provide an up to date continuing competency certificate for Martin Womack as the certificate on our records expired on 18th February 2018.

The dust suppression bowser was out of action at the time of the visit, this piece of machinery was being fixed at the time. No dust issues were identified at the time of the inspection.

Soil and rubble is accepted from Flintshire County Council (FCC), this waste contains contamination, the contamination is collected in a skip that is provided by FCC and returned to them.
