On **31st May 2019**, a routine unannounced site inspection was completed at **A Skip 2 U, Bridge Inn Padeswood, Mold, CH7 4JD** by the new regulating officer Carys Williams (Environment Officer) accompanied by Amy Henderson (Environment Officer). The site inspection was unaccompanied as director Rob Gardiner was not present at the time of the inspection.

The site was last visited by Natural Resources Wales (NRW) on 23rd June 2017, the previous inspection is detailed in Compliance Assessment Report: CAR_NRW0032010. There were no scores issued for the previous inspection, however concern was raised regarding the length of time gas canisters were stored on site. Despite this, it is accepted that there may be occasions when they arrive on site unintentionally in the bottom of a skip.

During this site inspection, 2 gas canisters were identified in the quarantine area. Please ensure these are removed from site as soon as possible, as these are not permitted waste types.

There was very little waste on site at the time of the inspection, all waste types, storage, segregation and general operations looked to be managed well. All waste was located within the permitted area. No issues with regards to dust or odour were identified.

On leaving site, officers met with Rob Gardiner (director). It was confirmed that a new waste carrier registration had recently been applied for (Reference: CBDU104619). Please ensure your waste duty of care transfer notes are updated to reflect the new waste carrier registration.
