### Monitoring Review

This Compliance Assessment Report has been produced following a review of all the monitoring data for 2020, to date. Natural Resources Wales undertake monitoring / sampling of the permitted discharge. The decision for Natural Resources Wales to monitor / sample the discharge was taken in line with Environment Agency's Operational Instruction 74 07. All samples are analysed by Natural Resources Wales Analytical Service, which is a United Kingdom Accreditation Service (UKAS) accredited laboratory.

Permit condition composition condition 8 states that the limits given in composition condition 8 of the permit shall not be exceeded the following limits. Limits within composition of condition 8 are: 80 milligrams per litre of suspended solid, 5 milligrams per litre of mineral oil, a pH value of 9 pH units or less than 6 pH units.

2020 Monitoring Data No breaches of permit limits except: -

12th March 2020: 118 mg/l suspended solids
