Liz Park and Malcolm Dines arrived to undertake an unannounced compliance visit. The main reason for the visit was to check compliance with the Regulation 36 Notice to Comply with permit conditions that was issued on 05 February 2020.

Whilst Liz and Malcolm signed the visitor book, Paul Morris - Assistant site Manager - was on the phone to Tim Richards. Liz Park then spoke with Tim Richards on the phone who informed Liz that he did not want us on site. A reason was given to Liz Park.

Tim Richards then returned to the site. Malcolm Dines and Liz Park tried to persuade Tim Richards that it would be in his best interests to allow them to complete the compliance visit but Tim Richards was adamant that he did not want the Officers on site. Tim Richards was informed that it is an offence to obstruct an authorised Officer in the course of his/her duty. This will be followed up as a separate matter.

Tim informed the Officers that he would like them to see the building for the picking line once it has been completed.

The officers observed from outside the office that the treatment shed was becoming full of waste leaving less space for the treatment of waste within the building.
