Reporting of emissions to water and sewer Q1 2020 (01/01 to 31/03/2020)

Requirements - Conditions 2.10.1 & 2.10.2 require the operator to maintain an emissions monitoring programme to the frequency detailed in table 2.10.1. The results of this monitoring shall be submitted for review as detailed in condition 4.1.2 and Schedule 2 of the permit.

Findings - Monitoring of emissions to surface water and sewer were received for the period 1st January - 31st March 2020 on 07/04/2020. Monitoring returns were submitted within the timescales required by the permit and were compliant with the relevant emission limit values.

Water and waste minimisation reports were received on 27/02/2020, as required by condition 2.4.1.2.
