Thank you for your application received on 26/09/2019. On the 15/10/2019 I tried calling you and I also sent you an email, regarding the request for further information listed below;

**Declaration**

In the case of a partnership, unless the partnership is a Limited Liability Partnership (LLP), the partnership itself cannot hold the permit. The individual partners in a partnership can hold a permit and therefore must sign the declaration. If you are an LLP can please provide me with your registration number. Otherwise can you ask your partner, Mrs Lisa Joanne Jones to sign in section 7d of the blank F1 form attached. There is no need to complete the rest of the form.

**Discharge Area**

Based on the information from your application form, I have calculated the required discharge area to be 1.54Ha. This is because we do not allow the disposal of waste sheep dip to the same area of land more than once per year. You have identified in your application a discharge area of 0.76Ha. In order for the required 2 disposals per year, I would be grateful if you could identify a second disposal area for the discharge on a map with the National Grid Reference. For your convenience I have included a copy of the site maps provided in your application.

**Land Use**

I would be grateful if you could confirm that the land where the disposal takes place is for agricultural use.

Please reply within 10 working days from the date of this letter. If we don't hear from you we must return your application and fee.
