A routine site inspection took place on 30TH May 2019. Present were Maldwyn Griffiths of Hefin Thomas (Agriculture) Limited and Julie Hughes NRW Regulating Officer.

The site is not fully operational due to the Operator not being able to comply with the Welsh Water discharge consent in relation to ammonia content. Whilst this issue is being resolved liquid waste is being tankered off site to the Llangefni waste water treatment works.

The draft environmental management system, which is a requirement of permit condition 1.1.1 (a) should be completed and a copy submitted to NRW by 1st July 2019.

Simon Thomas is acting as technically competent manager as per the requirement of condition 1.1.4 of the permit. Simon completed the Environmental Permitting Operators Certificate (EPOC) on the 21-22 February 2018 and has registered with WAMITAB to complete the level 4 certificate for Operators competence. The EPOC covers the Operator for 12 months whilst the WAMITAB is being completed. Please inform NRW of date WAMITAB will be completed and submit a copy of the certificate as soon as it is received.

A check of hazardous waste consignment notes was undertaken. The WCN were completed correctly however the notes should be completed with NRW headings and not the Environment Agency. Please amend when next sourcing new consignment notes.

Waste returns have all been submitted to NRW as required by the permit.

No breaches recorded against permit conditions during this visit.
