A pre-arranged visit took place on Monday 5th August 2019. Present were Julie Hughes, Regulating Officer, Miles Littlewood and Aled Owen of Watkin Jones & Son Ltd and Marco Muia of Oaktree Environmental Ltd.

Before signing in at the site office the Regulating Officer visited the yard where the operations under permit number EPR/NP3494FP are carried out.

The gates were secure, and the site unmanned. Works had been undertaken at the entrance to create a French drain to stop any runoff from the site.

The stockpile of screened waste has now been removed from site. Other material is still being stockpiled.

Photographs were taken:



At the office a review of the action plan from the previous visit was undertaken. All sections of the action plan have now been completed.

The notice board for the site has, again, been updated with a new emergency contact number due to changes in personnel.

Stephen Blay TCM has now left the company. Aled Owen is to register with WAMITAB to become the permits TCM however, in the interim period the role will be covered, when the site is operational, by Marco Muia of Oaktree Environmental Ltd.

It was discussed whether it would be suitable for Aled to do the EPOC course rather than the WAMITAB to provide Aled with a 12-month grace period however In line with the guidance:

The grace period of 12 months is only relevant for new permit applications (**page 8**), as you have an existing permit you will need to refer to **page 9**. Therefore, the EPOC certificate does not allow a 12-month grace period for your site.

The Environmental Management System (EMS) has been updated with a copy given to the Regulator. The site is now operating under version 1.5 of the EMS issued on the 4/4/19.

All waste returns have been submitted to NRW on time.

A check of a waste transfer notes (WTN) showed that some sections had not been completed correctly. Advice and guidance was given regarding providing the staff with toolbox talks regarding capturing the correct information required on the WTN to comply with Duty of Care
