A routine, pre-planned site visit took place on Thursday 1st August. Present were Robin Davies Operator and Julie Hughes Regulating Officer of NRW.

Prior to the visit a copy of the renewed WMITAB continuing competence certificate has been sent to NRW. The certificate covers Mr Davies until 5th June 2021.

A lot of work has been carried out on site since the previous visit. A large quantity of material has been processed to produce a product under the aggregates quality protocol.

Waste returns have been submitted on time for all quarters. The quarterly waste returns for January – March 2018 and April to June 2018 although submitted do not appear within the NRW electronic filing system. Please submit a duplicate copy of these by 12th August 2019 for our records.

Reminder – any 'Top soil' leaving the site should be accompanied by a waste transfer note and recorded on the waste returns as waste leaving the site. There is no quality protocol available for soils therefore the material will always be classed as waste.

Advice & Guidance – to ensure that records are available for the material leaving site as a product it would be useful if this information held on invoices/tickets was kept in spreadsheet format. This will help account for material leaving site as a product and making the figures balance against waste arriving on site.
