Since the previous visit the site office has moved locations and is back at the top of the site. The move was to enable a new haul road to be opened at the lower end of the site.

The opening of the new road enabled the material which had originally been deposited to be inspected. There were no issues found with contaminants/suitability.

The revised Ems is now in use. The daily site check sheets were available for inspection.

Following the previous site inspection work had been carried out to remove debris from the bed of the watercourse. This was now clear.

Waste returns have been submitted, these were checked for compliance with the permit. No issues.
