A routine, unannounced visit took place on 20th August 2019. Present were Regulating Officer Julie Hughes, Senior Environment Officer Ross Briscoe and Operator/Owner Mr Meurig Jones.

Weather at time of visit was dry and windy.

A planning application has been submitted to the Local Authority to extend the site. It was explained that there is no need to await the outcome of the application before applying for a permit variation.

When varying the permit, a new condition will be applied which will require the Operator to submit a Fire Prevention and Mitigation Plan (FPMP) to NRW. The Environmental Management System will also require updating when site improvements have been implemented.

A walk around the site did not highlight any issues.

Checks were made on the waste transfer notes which were found to be compliant with duty of care requirements.
