Upon arrival the entrance and yard was free from any mud and debris. We entered the yard via the office as the entrance gate was locked.

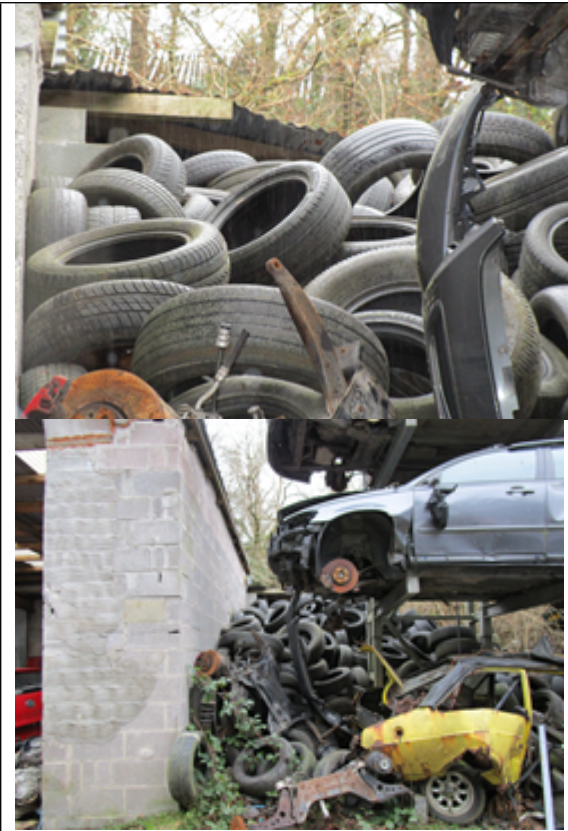


Site was operational during the inspection with one member of staff onsite carrying out his daily role. No members of the public was on site.

Cars that has not been de polluted were parked on the yard near the racks, the cars are not usually permitted to park there but due the christmas period where the site were close they had a bit of a backlog.

The yard was clean and tidy, however there were lots of tyres stored around the boundaries of the site. Provisions are in place to dispose of the tyres each month.





Engines and other mechanical bits were stored appropriately under cover and the depolluting shed had a vehicle being depolluted.



Moving forward provision are in place for a few of the vehicles and the lorry to be removed from site

No issues were noted relating to noise, odour, litter or pests.
