Weather conditions throughout the visit were dry and sunny. Upon arrival the entrance and yard was free from any mud/debris and was very clean and tidy.

Site was operational during the inspection with members of the public on site and the grabber actively moving the scrap metal onto the stock pile.



Construction work has been completed on parts of the site as stated in previous CAR form. ELV's and scrap metal was being stored on site, the quantities appeared within the permitted limits.



The area of the site along the rear of the shear/baling machine now has sealed drainage and benefits from a kerb as requested in the previous CAR form, meaning that any fluid or emission from site cannot flow directly onto neighbouring land (Open fields). Thank you for completing this.





Concreting had also taken place within the central area of the site where the previous concrete surface had worn away due to heavy plant movements. The concreted has now been laid and is looks great thank you.

New concrete panel walls have been erected around parts of the site the rest of the wall will be completed at some point.



The depolluting shed was neat and tidy with no stock plie.



No issues were noted relating to noise, odour, litter or pests.

No paperwork was viewed during this visit.
