Hazardous Waste Regulations - Premises notification requirements

Within Wales, under the Hazardous Waste Regulations if you produce or store over 500kg of hazardous waste in a 12 month period at your premises, the premises are required to be registered with Natural Resources Wales unless exempt.

You may already be aware of this requirement and your premises may already be registered with Natural Resources Wales, however if not, you may wish to consider if your premises should be registered.
