Natural Resources Wales has reasonable grounds to believe that the specified waste management operations will not resume within 2 months. Therefore all waste remaining on site must be removed including clearing plant, equipment used in the specified waste management operations, and emptying any sealed sumps and interceptors.

On the site the following was observed:

A pile of mixed waste including but not limited to wood, metal, plastic, insulation foam, blue pipes, wiring, concrete and a collapsed IBC.



Fridge dismantling plant with oil accumulating beneath the plant.



Deposits of wood, metal, dumpy bags, tyres, plastic piping, plastic, fridge/ freezer doors and a container of fluorescent tubes.

IBCs containing unidentified liquids.



Four 45 gallon drums of oil.



Three mini-skips containing various wastes including plastic, metal, tyres, fuel filters and insulation board.



Conveyor belt.

And other unidentified wastes.

As there is no office or postbox the Regulation 36 notice was attached to the fridge dismantling plant.
