Upon arrival to the site we went to the portacabins next door to introduce ourselves, there was no book or for us to sign in and no one accompanied us to the permitted site. We were unaccompanied throughout the visit.

The compound is small with wagons parked there, also skips which were not clearly marked with labels.





There was a lot of litter behind the skips which will require picking up also electrical items and other waste stored on the floor in the compound.





We also noticed a piece of the fence missing which will require fixing for security reasons. The compound was left insecure as there were no personnel on site.

No issues were noted relating to noise, odour, or pests.
No paperwork was viewed during this visit.
