Upon arrival the entrance and yard was free from any mud/debris and was very clean and tidy and displays the site board.

A mandatory health and safety induction had to be undertaken before inspecting the site.



The quarantine area had some construction work done to add a drain. Everything stored was compliant with the permit



The segregation shed had waste present and also was having construction work done to add a gully. The shed had some of the curtains open during the working day with no evidence of seagulls in the area.



The skips on site held waste and was correctly labelled and the whole area was in order.



No issues were noted relating to noise, odour, litter or pests.
