NRW Environment Officer Richard PALMER completed a site inspection of your site on the 10th September 2019, to assess compliance with your environmental permit. The weather was overcast but dry at the time of inspection. At the time of the inspection visit there was nobody on site.

It was recorded that there remains a large pile of inert waste material on site. The site seemed largely inactive with little or no evidence of activity of waste coming in or leaving the site. The site gates were locked, and access was restricted at this area, but the site was easily accessible as the rest of the site boundary is not secured.

Concerning the breaches from the previous site visit and recorded in the last CAR form there were no signs of any non-permitted waste types being accepted on to the site.

The infrastructure remains in poor condition as was recorded from the last site inspection, and the risk of runoff from the site remains high, although the waste types on site can be considered as low risk, pollution wise. Cat 4 Breach scored against *Condition 3.1.1 Table 3.1 and EMS Section 5.1*.

Similarly, the site security remains an issue as site is easily accessible and this allows for the possibility of illegal dumping and increase risk of illegal fires. Cat 4 breach scored against *Condition 1.1.1 and EMS 6.1*.

It seems as if the site is largely disused and if you wish to surrender your permit, please contact NRW to
