NRW Environment Officer Richard PALMER completed a site inspection of your site on the 10<sup>th</sup> September 2019, to assess compliance with your Waste Recovery Plan. The weather was overcast but dry at the time of inspection, but it had recently rained heavily.

NRW Environment Officer Palmer was shown around site by the Waste Recovery Plan permit holder Ed Shervington. Thank you for taking the time to show me around the site.

The site designated for the Waste Recovery appeared in the early stages of development at time of inspection and no issues were apparent concerning the quantity and quality of the waste types that were observed at time of inspection. There was not very much waste material that had been added to the site, and it was explained to NRW that the majority of the materials present was residual inert waste material from previous operations on the site.

NRW reminded Mr Shervington to adhere to the stipulations in the WRP regarding the quantities and quality of the waste materials to be used at this facility and retain all evidence of compliance.
