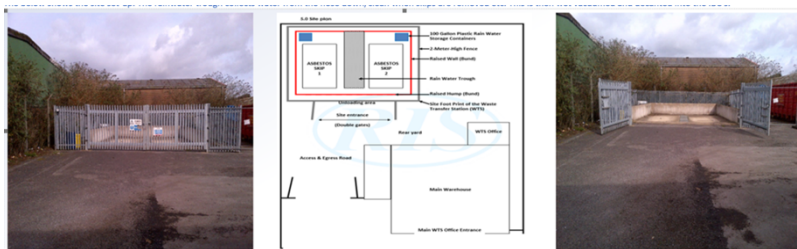

Bryan Stoughton clarified that the rainwater trough which runs the length of the secure compound containing the secure asbestos skips collects water from the hose down/clean when skips are removed etc. which is then wet vacuumed and decanted into the IBC's.

We noted on site multiple gas cylinders stored within temporary fencing. We now understand that the gas cylinders stored to the right of the asbestos compound at the time of our visit were empty awaiting collection and Bryan advised that a dedicated cage will be installed shortly, as you have at your Basildon Office.



We appreciate your immediate response to the waste being stored to the left of 'asbestos skip 1' within the secure compound where we advised that some general housekeeping was required, I understand this was actioned immediately.



Thank you for confirming submission of the quarter 4 2019 waste return by your TCM on 1st February 2020 and for promptly providing the documentation requested including a copy of Craig Richard Williams TCM WAMITAB certificate and an up-to-date Environment Management System/Working

Plan, we note this was amended in June as part your preparation for your ISO audits.

As way of a reminder, please ensure that a continuing competency course is undertaken by your TCM before their certificate is due to expire on 15th March 2020.
