Information was received by NRW on the 22/3/20 showing a discharge from the outfall serving the storm tank at Trebanos STW. Additional information supplied by DCWW in an email dated 24/3/20 corroborated the fact that there was a discharge. It was dry at the time of the discharge and it had not rained for a couple of days before so there should not have been a discharge from the storm tanks.

This is a breach of permit condition 2.3.4 a

Investigations have already been started by DCWW to investigate the cause of this problem. The work needs to continue and a solution needs to be implemented after discussion with NRW.

The information supplied that drew attention to this problem was limited but based on previous issues like this at this location, it was decided that the likely environmental impact would be low so the permit breach has been assessed as a category 3.
