We arrived on site to be told no records were written down, this is a breach of 4.1 conditions in the permit, which states:

" 4.1 Records

4.1.1 All records required to be made by this permit shall:

- a) be legible;
- b) Be made as soon as reasonably practicable;
- c) if amended, be amended in such a way that the original and any subsequent amendments remain legible, or are capable of retrieval; and
- d) be retained, unless otherwise agreed in writing by the environment agency, for at least 6 years from the date when the records were made

The operator shall keep on site all records, plans and the management system required to be maintained by the permit, unless otherwise agreed in writing by the Environment Agency.

Records for discharge of waste sheep dip shall include:

- a) Daily volumes of undiluted used/waste sheep dip discharged;
- b) rates of discharge;
- c) location and area of discharge;
- d) nature of used dip (marketing authorisation name will suffice);
- e) any materials added to dilute or treat the used / waste sheep dip, including water or slurry;
- f) for multiple discharges, records demonstrating compliance with only one permitted discharge per designated area of land per year shall be kept "

We gave the operator the NRW Sheep dip Toolkit form, which has a template to record the above details in.

The operator then showed us the sheep dip facilities which were of an adequate standard.

We advised the operator to keep the sheep dip container in a tray, even after use until its disposed of.
