This is the second clear inspection for Ystum Colwyn, whilst on site I made Mr Gittins and Mr Kynaston (consultant) aware of the eligibility of the installation to join the NRW Pig and Poultry Assurance Scheme. As explained, joining the scheme would mean the chosen certification Body will carry out a visit every year the farm remains in the scheme and NRW will visit once every three years.
