For the breach of section 1.1.1.(b) the score is now a catagory 3.

It has come to the attention or NRW that PAR Contarctors ltd do not have a competently trained **Technically Competent Manager (TCM)** named or in place on any active land spreading permit, this is a **Category 1 breach** contrary to **Section 1.1.1 of the SR2010 No4 Permit**. -"The operator shall manage and operate the operations using sufficient competent persons and resources".

Please provide proof in writing that Kevin Brook of 4r-group is acting as the **TCM** for land spreading.

Please provide proof that Kevin Brook has attained competency for land spreading by providing WAMITAB certification for land spreading.

Mr Edward Bennett is named as the **Nominated Competent Person (NCP)** for land spreading at **Bodwrog Farm** please provide proof that he is the acting NCP on site and please provide proof that Edward Bennett has attained competency for land spreading by providing WAMITAB certification for land spreading.
