Introduction

The purpose of the visit was to assess the compliance of Atlantic Salvage Company with their Environmental Permit EPR/VP3495FH.

Operations

Overall the condition of the site was good. Activity on site is very low level with the garage being used primarily for repairs and maintenance.

Technically Competent Manager

There is currently no Technically Competent Manager in place for the site.

Condition 2.3.1 of your Environmental Permit states;

“Any changes in the technically competent management of the site, the name of any incoming person and evidence that such a person has the required technical competence, shall be submitted to the Agency in writing within 5 working days of the change in management”

This is a breach of Condition 2.3 Fit and proper person and has been scored a Category 3 breach (A non-compliance which could have a minor environmental effect) under C1 General Management – Staff Competency/training.

Action – In order to comply with this condition please ensure that either you, or a member of your staff are enrolled on the WAMITAB course in order to achieve this qualification, or by hiring in an appropriately qualified person by 29/05/20.
